




The Division of Safety and Security annually presents the university's campus crime statistics and security information based on information reported and received during the previous calendar year. GW's 2018 Security and Fire Safety Report is provided in compliance with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act, also known as the Clery Act, and the Higher Education Opportunity Act.

The 2018 report provides safety and security information for each of GW's campuses, as well as for those properties frequented by students, faculty, and staff that are owned or controlled by GW but not immediately adjacent to the main campuses. Also included is information on the Division of Safety and Security, which includes the GW Police Department (GWPD), Health and Safety, and the Office of Advocacy & Support; policies and procedures for reporting crime; safety and security prevention and protection programs; fire safety; and other resources designed to assist in maintaining a safe GW community.

MISSION

The Division of Safety & Security

SAFETY.GWU.EDU

Safety and Security at the George Washington University is the comprehensive effort to provide a safe and secure campus for all university students, faculty, and staff. The Division of Safety & Security is led by the Associate Vice President for Safety and Security, and is comprised of Health & Safety and the George Washington University Police Department (GWPD).

HEALTH & SAFETY

Health & Safety includes the university's Environmental Health & Safety, Emergency Management, and the Emergency Medical Response Group (EMeRG). EMeRG provides basic life support (BLS) services on campus. The Health & Safety team is also responsible for enforcing the university's fire prevention and safety policies; providing OSHA inspections; and preparing for, responding to, and recovering from all hazards.

OFFICE OF ADVOCACY & SUPPORT

Formerly known as the Office of Victim Services, the Office of Advocacy & Support is committed to building a culture of care that supports and empowers GW community members who have been impacted by crime or violence, It provides services designed to raise awareness and address the needs of those affected by crime.

THE GEORGE WASHINGTON UNIVERSITY POLICE DEPARTMENT

The George Washington University Police Department (GWPD) protects and serves the university by providing professional law enforcement services while actively promoting community involvement through progressive community policing strategies and a commitment to education.



GWPD is a District of Columbia commissioned police force, and a member of the International Association of Campus Law Enforcement Agencies (IACLEA).

GWPD is responsible for providing police and security services for the Foggy Bottom and Mount Vernon campuses. There are more than 100 uniformed personnel, all of whom are Special Police Officers commissioned by, or security officers licensed by, the DC government. GWPD provides patrol service by car, Segways®, bicycle, and foot on a daily basis, 24 hours a day, and GW officers have the authority to make arrests on all GW-owned, leased, or controlled property. Additionally, coverage is provided on the Foggy Bottom and Mount Vernon campuses by staffing fixed posts throughout the campus.

A private contract security guard service provides access control security for the Virginia Science and Technology Campus. GWPD also hires students to work as Student Access Monitors (SAMs) in high-traffic residence halls and academic buildings on the Foggy Bottom Campus and the Mount Vernon Campus. These students are responsible for checking IDs and providing additional access control support.

The George Washington University Hospital maintains its own security service, with Special Police Officers who patrol on foot and provide access control for the hospital. GW Hospital Security is located on the first floor of the hospital and is led by a director who reports to the Chief Medical Officer. GWPD enforces GW regulations and both departments provide around-the-clock patrols, enforce federal and local statutes, and provide other services to the university community.

The George Washington University Police Department engages in state-of-the-art training for all campus police. Training covers a variety of topics to include criminal law, civil law, public relations, diversity and inclusion, interpersonal communication, crisis intervention, critical incident response, and all facets of protection of persons and property. Guest instructors from the

Metropolitan Police Department and other outside agencies, such as the FBI and the U.S. Secret Service, provide support and instructional expertise. The police officers also attend a 320-hour Campus Public Safety Institute sponsored by the Consortium of Universities of the Washington Metropolitan Area. In addition, all GWPD police and security personnel are certified in standard first aid and CPR.

Working Relationships

The George Washington University Police Department maintains a close working relationship with the Metropolitan Police Department (MPD), DC's municipal police force. GWPD occasionally works with other law enforcement agencies in the District of Columbia, including the FBI, Washington Metropolitan Area Transit Authority Police, U.S. Park Police, U.S. Capitol Police, and the U.S. Secret Service. The officers of GWPD and MPD communicate regularly on the scene of incidents occurring in and around the campus area. GW Police Detectives work closely with the investigative staff at MPD when incidents arise that require joint investigative efforts, resources, crime related reports, and exchanges of information. Memoranda of Understanding between GWPD and MPD are in place to outline the relationship between our agencies.

Reporting Procedures

GENERAL PROCEDURES FOR REPORTING A CRIME OR EMERGENCY TO GWPD

It is imperative that all crime and suspicious activity be reported to GWPD accurately and promptly. By working together, the university community and the police can reduce crime on campus. Members of the university community may report criminal activities or other emergencies in several different ways. We encourage all campus community members to promptly report all crimes and other emergencies directly to GWPD.

All GWPD incident reports involving students, with the exception of confidential reports, and reports of sexual violence (including sexual harassment), are shared with Enrollment and the Student Experience (ESE), as well as the Title IX Office. ESE will then refer all incident reports to the Office of Student Rights and Responsibilities for potential action, as appropriate. When GWPD receives a report, the responding officers initiate a preliminary investigation. Based on the results of the preliminary investigation and the presence of solvability factors, the Investigative Branch will conduct follow-up investigations. Additional information obtained via any investigation is also shared with the Office of Student Rights and Responsibilities. All GWPD incident reports involving students alleging sexual violence (including sexual harassment) are shared with the Title IX Office and the Office of Advocacy & Support, who then coordinate outreach and next steps. GWPD does not investigate these reports unless the complainant(s) wishes to file criminal charges.

GW University Hospital Security should be contacted when incidents, emergencies, or crimes occur in the George Washington University Hospital by calling (202) 715-5000. In response to a call, GWPD or Hospital Security will take the required action, either by dispatching an officer to the caller's location or asking the caller to report to GWPD to file an incident report.

REPORTING TO METROPOLITAN POLICE DEPARTMENT (MPD)

A person reporting a crime to GWPD has the right to report the crime to the Metropolitan Police Department (MPD) by calling **911** or using the DC non-emergency call center at **311**. GWPD officers regularly discuss this option with the victim of a crime and will assist the victim with that process. There are several recognized student organizations that occupy privately owned houses within the campus boundaries; however, GW does not have any officially recognized student organizations that have housing facilities "off-campus." If MPD is contacted about incidents occurring off-campus involving GW students, MPD will typically notify GWPD to inform GWPD of the situation. There is no official MPD policy requiring such notification involving private property. Students in these cases may be subject to arrest by MPD and university disciplinary proceedings through the Office of Student Rights and Responsibilities.

TO REPORT A CRIME

In the event anyone has information regarding crimes or emergencies on campus, they should immediately notify GWPD using free on-campus telephones which are located in the lobbies and corridors of many campus buildings or with a private phone by dialing:

CONFIDENTIAL REPORTING

You may make a confidential report to GWPD if: you are the victim of a crime and do not want to pursue action within the university system or the criminal justice system, or if you are a witness to a crime and do not want to reveal your identity. The purpose of a confidential report is to provide support while maintaining the reporting individual's confidentiality, and helping GWPD protect the safety of the GW community. Providing information also helps the university maintain accurate records regarding the number of incidents involving students, employees, and visitors; determine if there is a pattern of crime with regard to a particular location, method, or assailant; and alert the campus community to potential dangers when appropriate. Reports filed in this manner are included in GW's annual crime statistics, and when they involve allegations of sexual violence (including sexual harassment) they are made available to the university's Title IX Coordinator. You can call GWPD and ask that information remain confidential or use the TIPS Line (202-994-TIPS).

GW PAL

GW PAL, or personal alarm locator, is a free mobile application available in the iOS (Apple) or Android app stores. This university-built application acts as a mobile silent alarm, allowing users to request emergency assistance from GWPD. This app works by using the GPS location feature on smartphones, so if the user is outside of the Foggy Bottom or Mount Vernon campuses, the app will direct the user to call 911. GW PAL also allows users to submit crime tips to GWPD along with text, pictures, or video. Visit safety.gwu.edu/gwpal for more information.

EMERGENCY BLUE LIGHT PHONES

Emergency blue light phones are located on the Foggy Bottom and Mount Vernon campuses. Once activated, a large blue strobe light flashes from the top of the phone tower and the GWPD dispatcher is notified immediately. If you need assistance, see something that is suspicious, or see someone else who needs assistance, you should activate a blue light phone. Uniformed GWPD officers are responsible for checking the maintenance of blue lights regularly during their patrols. Members of the GW community can report any issues with blue lights by calling 202-994-6111.

TIPS LINE

GWPD operates a "TIPS" line to allow people to anonymously report security and safety related concerns and to provide GWPD with "tips" about criminal incidents or behavior on campus. Call (202) 994-TIPS (8477) to reach this recorded line. The TIPS line is monitored by the GW Chief of Police. Additionally, tips can be filed at GWPD's website via the online TIPS form at safety. gwu.edu/police. The TIPS line should NOT be used in emergency situations. For emergencies call (202) 994-



PARKING GARAGE "PANIC" BUTTONS

Panic buttons are generally located in parking garage stairwells below ground level and on the parking deck support columns approximately equidistant from the stairwells, and are visible by their bright orange signage. When a panic button is activated, the GWPD dispatcher is alerted of the location and immediately sends officers to the location to assist. Parking garage patrons should familiarize themselves with these buttons and their locations. Unlike the blue light phones, panic buttons will not flash a strobe light or connect you through a phone to the dispatcher. Panic buttons are most commonly located in garages and stairwells including the following areas:

Marvin Center Garage, Funger Hall Garage, Ross Hall Garage, the Medical Faculty Associates Garage, Academic Center Garage, Duquès Hall Garage, Media and Public Affairs Building Garage, 1957/1959 E Street Garage, Lerner Health & Wellness Center Garage, Dakota Garage, Amsterdam Hall Garage, South Hall Garage, Aston Garage, G Street Garage, West Hall Garage, SEH Garage, Shenkman Garage, and 2200 Pennsylvania Avenue Garage.

Timely Warnings

Students, faculty, staff, community members, and visitors are encouraged to report all crimes and public safety-related incidents to GWPD in a timely manner to aid in providing accurate and timely warning notices to the community when appropriate, and to ensure inclusion in the annual crime statistics. In the event of a serious incident which may pose an ongoing threat to members of the GW community, a GW Alert is sent to all students and employees on campus.

Alerts and updates to the GW community about any particular case may be distributed via blast email or text message, posted on the Campus Advisories website, and shared with *The GW Hatchet*. GW Alerts are usually distributed for the following Uniform Crime Reporting Program (UCR)/National Incident Based Reporting System (NIBRS) classifications: arson, criminal homicide, and robbery. Incidents of aggravated assault and sex offenses are considered on a case-by-case basis, depending on the facts of the case and whether there is a continuing threat to the campus community. GW Alerts may also be issued for other criminal incidents that impact the entire campus on a case-by-case basis.

Campus Security and Access

FOGGY BOTTOM CAMPUS

The Foggy Bottom Campus sits in the heart of the nation's capital, in a vibrant neighborhood bordered by the Potomac River, the Watergate complex, the White House, and the State Department. The campus is home to the majority of GW's schools and administrative offices, as well as classrooms, libraries, residence halls, and the university's hospital. Most academic and administrative buildings are open to the public, at a minimum, during normal business hours. Most facilities have individual hours, and the hours may vary at different times of the year. Access to some of these buildings is also controlled by card readers after normal business hours. All of these buildings have varied levels of access. GWPD is located at Rome Hall 101. GWPD officers patrol the academic and administrative buildings on a regular basis. For information about the access protocol for a specific building, contact the building manager or department head.

MOUNT VERNON CAMPUS

The Mount Vernon Campus (MVC) is located in Washington, DC's Foxhall neighborhood on the former site of Mount Vernon College, a women's institution with a long heritage of its own. Institutional and commercial venues, as well as homes, embassies, and diplomatic residences, surround the campus. The Mount Vernon Campus is open to the public, at a minimum, during normal business hours. An inter-campus shuttle with stops at Funger Hall on the Foggy Bottom Campus and Somers Hall on the Mount Vernon Campus, transports faculty, staff, and students to and from the Foggy Bottom and Mount Vernon Campuses. For more information on transportation to the MVC, visit transportation.gwu.edu/mount-vernon**shuttle-vern-express**. The Whitehaven entrance is accessible 24 hours a day and should be used in accordance with the policies established by the Mount Vernon Campus staff. GWPD is located in Ames Hall on the Whitehaven entrance. The Academic Building, Ames Hall, Acheson Science Center, the Hand Chapel, and the Lloyd Gymnasium are typically secured during the evening hours. The schedules for these buildings vary and are available online at mountvernon.gwu.edu/academic-administrativeand-event-facilities. Eckles Library hours vary throughout the year, so it is best to check the library schedule to determine the operating hours. The Library's 24-hour computer lab is located in the front foyer of the library. While students have access to the lab at all times, the remainder of the library is not accessible after the posted business hours.

Residence Halls

Access to residence halls is restricted to residents, their approved guests, and other approved members of the university community. Most buildings have a 3-tap system for entry, which requires that all who enter the building must tap in at three access control points prior to entering a residential space. Each resident has a front door key or a GWorld card which allows access to the residence halls. Guests who do not reside in one of GW's







residence halls must be accompanied at all times by the resident they are visiting. Residents are cautioned against permitting strangers to enter the buildings and are urged to require individuals seeking entry to use their access cards. GWPD officers patrol the residence halls on a regular basis and work with Resident Advisors, Residence Directors, and Area Coordinators to enforce security measures.

Security Maintenance

Facilities and landscaping are maintained in a manner that minimizes hazardous conditions. GWPD regularly patrols both campuses and reports malfunctioning lights and other unsafe physical conditions to Facilities Management for repair. Other members of the university community should promptly report equipment problems to GWPD or to Facilities Management.

VIRGINIA SCIENCE AND TECHNOLOGY CAMPUS

The GW Virginia Science and Technology Campus (VSTC), established in 1991, is strategically located in the Northern Virginia technology corridor near Dulles International Airport in Ashburn, VA. The campus focuses on interdisciplinary STEM-H research, including biological and health sciences, big data and analytics, high-performance computing, and energy science and technology. Degree and certificate programs are offered by many of GW's schools and colleges. Numerous programs are designed to meet the needs of professional students with evening, weekend, and online courses.

There are no residence halls on the Virginia Science and Technology Campus. The VSTC is open to the public at a minimum, during normal business hours. Access to Discovery Hall, Enterprise Hall, Exploration Hall, Innovation Hall, and Research Place is via a GWorld card or security guard access. Access after normal business hours is by GWorld card. Requests for GWorld access cards can be processed by the Facilities Department at the VSTC by appointment only. For more information, please visit gworld.gwu.edu/locations-hours. Hours of operation for all buildings are available online at virginia.gwu.edu/buildings. An intercampus shuttle that departs from the Foggy Bottom Campus at Funger Hall transports faculty, staff, and students to and from VSTC, with stops at Enterprise Hall, Exploration Hall, Innovation Hall, and Research Place. For more information on transportation, see virginia.gwu.edu/shuttles. The facilities and landscaping are maintained to minimize conditions that might pose a danger. Malfunctioning lights and other unsafe conditions should be reported to the Facilities Department at (571) 553-3501.

ALEXANDRIA EDUCATION CENTER

The Alexandria Education Center is a George Washington University off-campus graduate education center, serving working professionals. The Center is located in Alexandria, Virginia, and is conveniently located four blocks from the King Street Metro Station, accessible by the blue and yellow lines. This center features a community counseling center, 11 classrooms, an art gallery, and studio space.

Panic buttons are in place at the reception desk, and every classroom has an intercom that calls reception.

Access to the Facility

The Center's administrative offices are open Monday through Friday from 9:00 a.m. to 9:00 p.m. The Center's facilities are normally open for classes from 9:30 a.m. to 9:00 p.m. Monday through Thursday, some Fridays, and Saturdays from 8:30 a.m. to 6:00 p.m. Note: The Center is closed on Sundays and GW holidays. The facility may be opened during other hours as coordinated with the Director of the Alexandria Education Center.

*This campus is designated as a commuter campus.

CORCORAN FLAGG BUILDING

The Corcoran School of the Arts and Design bridges GW's academically robust programs in the arts with the Corcoran's creative and inspired scholarship. Part of GW's Columbian College of Arts and Sciences, the school functions as an incubator for artists and practitioners in arts-related fields, and serves to enrich students who are taking classes in other areas of the university. As such, it provides a platform for engagement that bridges creative expression and practical application with the breadth and depth of the larger liberal arts education.

Access to the Facility

The Corcoran Flagg Building is open Monday through Friday from 7:00 a.m. until 11:00 p.m., and on Saturday and Sunday from 9:00 a.m. until 9:00 p.m. The main entrance to the building is located on 17th street. The main offices for the Corcoran School and the Interior Architecture, Design and Studio Arts degrees are located in "Administrative Offices" to the left of the South Atrium.

ARLINGTON EDUCATION CENTER

The Arlington Education Center is a George Washington University off-campus graduate education center, serving working professionals and offering an assortment of master's degree programs, bachelor's degree programs, and graduate certificates.

The Arlington Education Center is located in the heart of Ballston at the intersection of N. Glebe Road and Fairfax Drive, three blocks from the Ballston Metro Station (Orange/Silver Lines). The center features 24,000 square feet of learning space with computer labs, a homework lab, student and faculty lounges, and fully equipped meeting rooms and classrooms. The classrooms, offices, and computer labs are locked at all times when not is use.

Panic buttons are in place at each reception desk, and every classroom has an intercom that calls reception.

Access to the Facility

The Arlington Education Center is open Monday through Friday from 9:00 a.m. until 9:00 p.m. The Center is open Saturdays from 8:30 a.m. until 6:00 p.m. The Center is closed on Sundays and GW holidays.

HALL OF THE STATES BUILDING

400 North Capitol Street, NW, Washington, DC 20001

The Hall of the States Building is the off-campus location for the GW Master of Professional Studies in the field of Legislative Affairs program.

Access to the Facility

The Hall of the States Building is located directly across the street from the United States Capitol Complex and is easily accessible from Metro's Union Station Red Line station and several Metrobus stops. GW rents three or four conference rooms Monday through Thursday on the second floor of the building and holds class in the early evening, generally from 6:00 p.m. to 8:00 p.m. Meter parking is usually available. Building garage parking is also available, for an hourly fee. The Union Station metro is a two-block walk.

The Hall of the States Building has a guard posted at the entrance to the building 24 hours a day. All students must be issued a temporary identification card (valid for same day only) each time they attend class. In addition, contract security guards hired by the Hall of the States building management are posted at strategic locations throughout the building, 24 hours a day. Watkins Security Company is responsible for the security of the building.

Access to the Facility Hampton Roads Education Center

The HREC administrative offices are open Monday through Friday from 8:15 a.m. to 5:30 p.m. The HREC facilities are normally open for classes from 5:00 p.m. to 10:00 p.m. Monday through Friday, and Saturdays 8:00 a.m. to 5:00 p.m.

The TowneBank Building is open from 7:00 a.m. until 6:30 p.m. weekdays. After-hours and weekend access is by swipe card and/or keypad with speaker. Students using the keypad identify themselves by name and the class they are attending before access is granted. After-hours and weekend access is part of the security system administered by Olympia, the building's property management.

Crime and public safety incidents at the Hampton Roads Center in the TowneBank Building in Newport News should be reported to the Newport News Police Department at 911 (emergency) or by calling (757) 247-2500 (non-emergency).

Crime Statistics

The information below provides context for the crime statistics reported as part of compliance with the Clery Act.

The statistics in this report are published in accordance with the standards and guidelines used by the FBI Uniform Crime Reporting Handbook and relevant federal law. GWPD submits the annual crime statistics published in this report to the Department of Education (ED). The statistical information gathered by the Department of Education is available to the public through the ED website. In addition, a daily crime log is available for review 24 hours a day on the GWPD website, at safety.gwu.edu/reports-and-records. The procedures for preparing the annual disclosure of crime statistics include reporting statistics to the university community obtained from the following sources: the GW Police Department (GWPD), the DC Metropolitan Police Department (MPD), the GW University Hospital Security Department, the Federal Bureau of Investigations (FBI), United States Capitol Police, the U.S. National Park Service Park Police, and non-police officials. For statistical purposes, crime statistics reported to any of these sources are recorded in the calendar year the crime was reported. We also communicate with departments at institutions our students travel to throughout the academic year in order to obtain the necessary statistics.

A written request for statistical information is made on an annual basis to all non-police officials who include campus security authorities. A designated campus authority includes, but is not limited to, university deans, directors, department heads, residence life staff, and counselors. Statistical information is requested and provided to GWPD by the employees at the Colonial Health Center, even though they are not required by law to provide statistics for the compliance document. Members of the Sexual Assault Response Consultative (SARC) Team, the Title IX Office, and the Office of Advocacy & Support also provide statistics to GWPD about cases they have dealt with where the survivor chose not to report the incident to GWPD or MPD.

C FINERGENCY THE REPORT OF THE PARTY OF THE

Definitions of Categories

The following definitions come from a variety of sources, including the Department of Education's Handbook for Campus Safety and Security Reporting, and definitions of domestic violence, dating violence, and stalking are adapted from the amendments made to the Violence Against Women Reauthorization Act of 2019.

Aggravated Assault: An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm. It is not necessary that injury result from an aggravated assault when a gun, knife, or other weapon is used which could or probably would result in a serious potential injury if the crime were successfully completed.

Arson: Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling, house, public building, motor vehicle or aircraft, personal property, etc.

Bias-Related Acts: Behaviors that express hostility against a person, property or group because of their real or perceived age, color, disability, gender identity or expression, marital status, military or veteran status, national origin, personal appearance, political affiliation, race, religion, sex, sexual orientation, or any other unlawful basis in any university-recognized area of student life. Bias acts may be verbal, graphic, or physical in nature. These behaviors often contribute to creating an unsafe or unwelcoming environment for individuals and social identity groups. Acts can qualify as bias acts even when delivered with humorous intent or presented as a joke or a prank.

Burglary: The unlawful entry of a structure to commit a felony or a theft. For reporting purposes this definition includes: unlawful entry with intent to commit a larceny or a felony; breaking and entering with intent to commit a larceny; housebreaking; safecracking; and all attempts to commit any of the aforementioned

Dating Violence: An act of violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the survivor. For this purpose the existence of such a relationship shall be determined based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship. Dating violence includes without limitation sexual or physical abuse or the threat of such abuse, but excludes acts covered under the definition of 'domestic violence.'

Destruction/Damage/Vandalism of Property: To willfully or maliciously destroy, damage, deface, or otherwise injure real or personal property without the consent of the owner or the person having custody or control of it.

Disciplinary Referrals: Individuals referred to the Office of Student Rights and Responsibilities (OSRR) for liquor law, drug law, and illegal weapons violations. The numbers include incidents that are reported via GWPD incident reports and reports provided directly to OSRR from other members of the GW community.

Domestic Violence: A felony or misdemeanor crime of violence committed by: (1) a current or former spouse or intimate partner of the reporting party; (2) a person with whom the reporting party shares a child in common; (3) a person who is cohabitating with, or has cohabitated with, the reporting party as a spouse or intimate partner; (4) a person similarly situated to a spouse of the reporting party under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred; or (5) any other person against an adult or youth survivor who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred, which under District of Columbia law includes roommates.

Drug Abuse Violations: The violation of laws prohibiting the production, distribution, and/or use of certain controlled substances and the equipment or devices utilized in their preparation and/or use. The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation, or importation of any controlled drug or narcotic substance. Arrests for violations of state and local laws, specifically those relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs.

Fondling: The touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the survivor, including instances where the survivor is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental incapacity.

Hate Crime: The District of Columbia's Bias-Related Crime Act of 1989 defines a bias-related crime (i.e., hate crime) as a criminal act and/or attempting, aiding, abetting, advising, inciting, conniving, or conspiring to commit a criminal act (such as arson, assault, burglary, injury to property, kidnapping, manslaughter, murder, rape, robbery, theft, or unlawful entry) based on the actual or perceived race, color, religion, national origin, sex, age, marital status, personal appearance, sexual orientation, gender identity or expression, family responsibility, homelessness, physical disability, matriculation, or political affiliation of a victim of a criminal act. Hate crimes under various federal laws have similar definitions. Most speech is not a hate crime, regardless of how offensive it may be.

Incest: Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

Intimidation: To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

Larceny/Theft: The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. Attempted larcenies are included. Embezzlement, confidence games, forgery, worthless checks, etc., are excluded.

Liquor Law Violations: The violation of state or local laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, or use of alcoholic beverages, not including driving under the influence and drunkenness.

Manslaughter by Negligence: The killing of another person through gross negligence.

Motor Vehicle Theft: The theft or attempted theft of a motor vehicle, including cases where automobiles are taken by persons not having lawful access even though the vehicles are later abandoned, including 'joyriding.'

Murder and Non-Negligent Manslaughter: The willful (non-negligent) killing of one human being by another.

Rape: The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.

Robbery: The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force, violence, and/or causing the victim fear.

Simple Assault: An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

Stalking: Engaging in a course of conduct directed at a specific person, including without limitation by means of following, monitoring, observing, surveilling, threatening, or communicating to or about a person or interfering with a person's property, that would cause a reasonable person to fear for the person's safety or the safety of others or suffer significant mental suffering or anguish that may, but does not necessarily require, medical or other professional treatment or counseling.

Statutory Rape: Sexual intercourse with a person who is under the statutory age of consent.

Weapons Law Violations: The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices, or other deadly weapons.



Definitions of Geography

On-Campus: Any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of or in a manner related to the institution's educational purposes, including residence halls; and any building or property that is owned by the institution but controlled by another person, is frequently used by students, and supports institutional purposes.

Note: Statistics for university housing facilities are recorded and included in both the all on-campus category and the on-campus residential only

Non-Campus Building or Property: Any building or property owned or controlled by a student organization that is officially recognized by the institution; or any building or property owned or controlled by an institution that is used in direct support of or in relation to the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution. Residence halls that are located outside the campus boundaries are captured in the Non-Campus category.

Public Property: All public property, including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus or immediately adjacent to and accessible from the campus. The GW crime statistics do not include crimes that occur in privately owned homes or businesses within or adjacent to the campus boundaries.


Definitions of Reporting Methods

Reported to GWPD: Crime statistics from all incidents that were reported to GWPD. If an incident was reported to both GWPD and MPD, the statistics would be counted in this column. Incidents reported to the GW University Hospital Security Department are also included in this column.

Reported to MPD and Metro Transit Police: Crime statistics from incidents that were reported to MPD, MTP, or other law enforcement agencies, but NOT reported to GWPD. These incidents could have occurred on/in on-campus property, non-campus property or public property. The crime statistics provided are based on the crime definitions in the DC Crimes Code, not based on the Uniform Crime Reporting Program (UCR)/National Incident Based Reporting System (NIBRS), as required by the federal law.

Reported to Non-Police: Crime statistics from incidents reported to officials at the institution who are defined by federal law as Campus Security Authorities because they have significant responsibility for student and campus activities. Including, but not limited to, Sexual Assault Response Consultative (SARC) Team members, Resident Assistants, Residence Directors, Area Coordinators, Student Access Monitors, the Title IX Office, and Office of Student Rights and Responsibilities staff. CSA online reporting is also available through GWPD's website at safety.gwu. edu/clery.

Unfounded: When reported to campus security authorities, but omitted from the crime statistics because they were later determined through investigation by sworn or commissioned law enforcement personnel to have been false or baseless when made.



Hate Crimes

The George Washington University strives to foster a safe and healthy learning environment that embodies diversity and inclusion of all members of the GW community. The hate crime statistics are separated by category of prejudice. The numbers for most of the specific crime categories are part of the overall statistics reported for each year. The only exceptions to this are the addition of simple assault, intimidation, and any other crime that involves bodily injury that is not already included in the required reporting categories. If a hate crime occurs where there is an incident involving intimidation, vandalism, larceny, simple assault, or other bodily injury, the law requires that the statistic be reported as a hate crime even though there is no requirement to report the crime classification in any other area of the compliance document. Note: A hate-related crime is not a separate, distinct crime, but is the commission of a criminal offense which was motivated by the offender's bias. For example, a subject assaults a victim, which is a crime. If the facts of the case indicate that the offender was motivated to commit the offense because of his/her bias against the victim's race, sexual orientation, gender, religion, ethnicity, national origin, gender identity, or disability, the assault is then also classified as a hate crime.

Crime Prevention

The George Washington University offers many programs designed to inform students and employees about campus security procedures and practices. A common theme of all awareness and crime prevention programs is to encourage students and employees to be responsible for their own safety and for the safety of others on campus. Crime prevention programs on personal safety and security are sponsored by various campus organizations throughout the year. The programs include general crime prevention and security awareness programs, such as safety education forums, programs, and discussions about topics such as alcohol abuse, dating violence, self-defense, fire safety, emergency response and evacuation procedures, sexual assault prevention, and theft prevention.

The Division of Safety & Security, Enrollment and the Student Experience, including GW Residence Hall Staff, and a Title IX Coordinator participate in forums, town hall meetings, and programs in residence halls to explain university security, public safety, and fire safety measures and procedures at GW with all incoming students and their parents from June-August during summer orientation (Colonial Inauguration). Throughout the academic year, Enrollment and the Student Experience conducts programs on information regarding alcohol education, fire safety, personal safety, and crime prevention for the GW community. New employee orientation includes the distribution of crime prevention and fire safety materials to all new employees on a monthly basis. Health & Emergency Management Safety (HEMS) participated in and/or conducted four fire safety educational programs for students and employees. HEMS conducted 100 educational programs and held an annual Safety Expo at the Foggy Bottom and VSTC campuses each September as a part of National Preparedness Month. The Expo provides a forum for GW Safety and Security units and approximately 21 public safety agencies from the Washington, DC area to educate and provide safety and security tips to the GW community.

Members of GWPD conducted approximately 200 crime prevention and general security and safety awareness presentations for students and employees of the university. During these presentations, information is provided on topics such as: crime prevention tips, statistics on crime at GW, fire safety, and campus security procedures and practices. Finally, the Division of Safety & Security organizes and sets up crime prevention and education display tables at various locations throughout the year. This provides an opportunity for the staff to disseminate safety-related information, as well as to answer individual questions.

TIPS FOR YOUR SAFETY

- Limit your alcohol consumption and leave social functions that appear to be getting out of control.
 Remember to call GWPD or MPD for help at the first sign of trouble.
- Try to avoid walking alone at night. Travel with friends or use university transportation services.
- Always lock the door to your residence hall room, whether or not you are there.
- Keep windows closed and locked when you are not at home.
- Do not hold doors open to residence halls or other protected locations.
- Be aware of your surroundings. Instead of texting or looking down at the ground, watch the cars and people around you.
- Never leave valuables unattended.
- Carry your keys and GWorld card at all times and do not lend them to anyone.
- Lock up bicycles and motorcycles. Lock car doors and close windows when leaving your car.
- Do not leave valuables in your car, especially if they can be easily noticed.
- Engrave serial numbers or owner's recognized numbers, such as a driver's license number, on items of value.
- Inventory your personal property and insure it appropriately with personal insurance coverage.

Transportation Services

GW Safe Ride, formerly known as 4Ride, provides a free and safe ride to/from Foggy Bottom Campus residence halls and academic buildings during late night hours for students, faculty, and staff who prefer to not walk alone. This safe ride service operates seven days a week (Sunday-Saturday) from 8:00 p.m. until 4 a.m.

Self-Defense Classes

GWPD Self Defense instruction covers basic stance, strikes, and blocks. Each technique is specifically designed to be utilized in the event of an attack. The program assists participants in gaining confidence in their own abilities, as well as making them more aware of their surroundings. The course is offered several times during the academic year and is free to all members of the GW community. To pre-register for a session, submit your request through safety.gwu.edu/training.

Operation Identification

GWPD promotes the Operation Identification program, engraving serial numbers or owner's recognized numbers (e.g. driver's license number) on items of value, and makes engravers available upon request free of charge by GWPD. Notification of Missing Students

If a member of the university community has reason to believe that a student who resides in on-campus housing has been missing, he or she should immediately notify GWPD at (202) 994-6111. GWPD will generate a missing person report and initiate an investigation. After investigating, GWPD will notify MPD and the Area Coordinator and the Director on Call will notify the student's emergency contact as soon as practicable and no later than 24 hours after the student is determined to be missing. If the missing student is under the age of 18 and is not an emancipated individual, GW will also notify the student's parent or legal guardian as soon as practicable and no later than 24 hours after the student is determined to be missing.

In addition to registering an emergency contact, students residing in oncampus housing have the option to identify, confidentially, an individual to be contacted by GWPD in the event the student is determined to be missing for more than 24 hours. If a student has identified such an individual, GW will notify that individual as soon as practicable and no later than 24 hours after the student is determined to be missing. A student who wishes to identify a confidential contact person can do so through the GW Housing application form. The student's confidential contact information will be accessible only by authorized campus officials and law enforcement as appropriate.

Sexual and Gender-Based Harassment and Interpersonal Violence

It is a priority of the university to provide an academic and work environment free from sexual harassment. The university prohibits sexual and gender-based harassment and interpersonal violence on its campuses and other property, as well as in connection with its programs and activities. The university's Sexual and Gender-Based Harassment and Interpersonal Violence Policy prohibits sexual and gender-based harassment, sexual assault, sexual exploitation, intimate partner violence, stalking, retaliation, and complicity (collectively, "Prohibited Conduct"). The university encourages all members of the university community to report any such conduct, and will investigate and address complaints in a prompt, fair, and impartial manner. To that end, the university further prohibits any form of retaliation against a person who participates in proceedings under the policy.

The Sexual and Gender-Based Harassment and Interpersonal Violence Policy provides comprehensive information and guidance about resources, reporting options, and prompt and equitable resolution options relating to Prohibited Conduct at GW. The policy may be accessed from GW's policy website (my.gwu.edu/files/policies/SexualHarassmentFINAL.pdf), and is also linked on the Haven website (haven.gwu.edu).

The Sexual and Gender-Based Harassment and Interpersonal Violence Policy contains the following definitions, among others:

Intimate Partner Violence is any assault, threat, physical abuse, act of violence or threatened act of violence, as defined below, that occurs between individuals who are involved or have been involved in a sexual, dating, spousal, or other intimate relationship (often referred to as dating violence); or between individuals with a familial or domestic relationship, excluding violence between roommates (often referred to as domestic violence).

Threats are words or actions intended, causing, or reasonably likely to cause fear, pain, harm, injury, emotional distress, or damage to any person or property. Threats may include Assault as it is defined in the Code of Student Conduct (placing a person in fear of imminent physical danger or injury through the use of electronic, verbal, or physical means).

Violence is the use of physical force with intent, effect, or reasonable likelihood of causing pain, harm, injury, or damage to any person or property. Violence may include physical abuse as it is defined in the Code of Student Conduct (committing physical abuse and/or battery of any person).

In addition, when in the context of a current or former relationship, intimate partner violence may include any form of prohibited conduct (such as sexual and gender-based harassment, sexual assault, sexual exploitation, stalking, and retaliation as defined in the policy). The definition of intimate partner violence is consistent with the definitions of dating violence and domestic violence set forth in the Clery Act. When determining whether the reported conduct meets the Clery definition, whether there has been a domestic or dating relationship will be determined by a review of its length, type, and frequency of interaction.

Sexual Assault is any physical sexual act against any person, including any sexual intercourse or sexual contact, without consent or where the other person is incapable of giving consent due to incapacitation, age, family relation to the other person, or intellectual or other disability.

Sexual Intercourse is any act of vaginal or anal penetration, however slight, by a person's penis, finger, other body part or an object, or, regardless of whether penetration occurs, any oralgenital contact.

Sexual Contact is any intentional touching of a person's breasts, buttocks, groin, genitals, or other intimate parts. Touching may be over or under clothing and may include one party touching another, the one party making another touch them or another person, or the one party making the other touch his or her own body.

Stalking is engaging in a course of conduct (i.e., more than one act) directed at a specific person, which would cause a reasonable person (under similar circumstances and with similar identities to the complainant) to experience fear or substantial emotional distress, or to fear for their safety or the safety of others. Acts that together constitute stalking may be direct actions or may be communicated by a third party, and can include, but are not limited to, acts in which the stalker directly, indirectly, or through third parties, by any action, method, device, or means, follows, monitors, observes, surveils, threatens or communicates to or about a person, or interferes with a person's property or movement. It may also include threats of harm to self, others, pets, or property; pursuing or following; nonconsensual (unwanted) communication by any means; unwanted gifts; trespassing; and surveillance or other related types of observation. Stalking includes cyberstalking through electronic media, like the internet, social networks, blogs, cell phones, or text messages. Substantial emotional distress means significant mental suffering or anguish that may, but does not necessarily, require medical or other professional treatment or counseling.

Consent requires voluntary, informed, and freely given agreement, through words and/or actions, to engage in mutually agreed upon sexual intercourse, sexual contact, or other sexual activity. Consent cannot be obtained through force, where there is a reasonable belief of the threat of force, or by taking advantage of another person's incapacitation. In evaluating whether consent has been freely sought and given, the university will consider the presence of any force, threat of force, or coercion; whether a party had the capacity to give consent; and whether the communication (through words and/or actions) between the parties would be interpreted by a reasonable person (under similar circumstances and with similar identities) as a willingness to engage in a particular sexual act.

REPORTING TO LAW ENFORCEMENT

To report an act of violence in progress, or that has concluded, on GW's Foggy Bottom and Mount Vernon campuses, call GWPD at (202) 994-6111 or call the Metropolitan Police Department at 911. If the act of violence is in progress or imminent on GW's Virginia Science and Technology campus or any other noncampus location, dial 911 to reach local law enforcement.

To report a threat that is not imminent, call GWPD at (202) 994-6110. In the District of Columbia, calls may also be made to the Metropolitan Police Department non-emergency line at 311. Reports may also be made on the "Report Threatening Behavior or Other Behavioral Concerns" form located on the GWPD website at safety.gwu.edu/services-we-offer.

Incidents involving sexual and gender-based harassment and/ or intimate partner violence (including domestic and dating violence) which may be criminal in nature, and members of the university community who believe they have experienced either may, if they wish, file reports with GWPD or local law enforcement. Assistance to file reports is available from GWPD and the Office of Advocacy & Support.

The university encourages prompt reporting of prohibited conduct to the Title IX Coordinator and law enforcement.

In all cases involving sexual and gender-based harassment and/ or intimate partner violence, it is important to consider preserving evidence. As time passes, evidence may dissipate or become lost or unavailable, which makes investigation, possible prosecution, disciplinary proceedings, or obtaining orders of protection more difficult. Regardless of whether a report is filed with local law enforcement, individuals should preserve all evidence that could be relevant to any criminal charges that may be brought or that might be needed to obtain a protection order.

ASSISTANCE FOR COMMUNITY MEMBERS

Members of the university community may obtain information about resources relating to prohibited conduct from the Office of Advocacy & Support by calling (202) 994-0443, as well as from the Title IX Office at (202) 994-7434.

Members of the university community who have been subjected to acts of violence, including sexual assault, domestic violence,

and dating violence, are encouraged to obtain medical attention to evaluate for possible injury. GW students may obtain medical attention from the Colonial Health Center (202-994-6827) and a sexual assault forensic exam may be performed at the MedStar Washington Hospital Center (844-443-5732), which is located at 110 Irving Street, NW, Washington, DC 20010. Please note that the George Washington University Hospital does not offer sexual assault forensic exams, but students can receive assistance with making traveling arrangements to the MedStar Washington Hospital Center by contacting SARC at 202-005-7222. Visit haven.gwu.edu/medical-care for more information.

GW's Sexual Assault Response Consultative (SARC) Team may provide guidance regarding sexual harassment. SARC Team members are not professional counselors, but they can identify sources of medical, legal, counseling, and academic assistance and explain reporting options both at the university and externally (such as filing a police report). They can be reached 7 days a week, 24 hours a day, at (202) 994-7222. More information about the SARC Team is available at haven.gwu.edu/sexual-assault-response-consultation-team-sarc.

Students may obtain confidential medical and counseling services at the Colonial Health Center, which can be reached 7 days a week, 24 hours a day, at (202) 994-5300, option 3.

Community members may obtain further information about resources available to address incidents involving violence and threats from the university's Title IX Coordinator, (202) 994-7434, shrc@gwu.edu; Enrollment and the Student Experience, (202) 994-6710, students@gwu.edu; and haven.gwu.edu, a centralized location for information and resources relating to sexual and gender-based harassment and intimate partner violence.

Individuals may apply for civil protection orders from local courts. Information about protection orders and other steps that can be taken in such cases is available from the Office of Advocacy & Support within the Division of Safety and Security. You can contact the Office of Advocacy & Support by emailing ovs@gwu.edu or calling (202) 994-0443.

Community members may also obtain assistance and information relating to incidents involving domestic violence, dating violence, sexual assault and/or stalking from the organizations not affiliated with the university identified in the section of this report entitled "Response to Sexual Violence."

PROCEDURES TO ADDRESS INCIDENTS

The university has established specific procedures to address incidents involving prohibited conduct. These procedures involve an intake and an initial assessment followed, as appropriate, by an alternative or disciplinary resolution. These procedures will be administered in a fair and impartial manner by trained Title IX Office staff who understand the difficult and sensitive issues involved.

Intake and Initial Assessment. Any member of the university community may request an intake meeting regarding an incident by contacting the Title IX Office's Assistant Director of Sexual Assault Prevention and Response at (202) 994-7434 or at shrc@ gwu.edu. The intake meeting will be scheduled promptly, and during the meeting the circumstances underlying the report will be assessed and the immediate safety and emotional wellbeing of the individual will be addressed. The individual will have the opportunity to ask questions, and will be provided written information with on- and off-campus resources concerning counseling, health, survivor advocacy, legal assistance, and visa and immigration assistance. In addition, an individual's right to file a report with law enforcement, seek a civil protection order, and seek medical treatment, as well as the importance of preserving evidence, will be discussed. The intake meeting will also detail the disciplinary and alternative resolution procedures and the individual's expressed preference for a manner of resolution. If the individual raises concerns/potential barriers to proceeding, the Title IX Office will attempt to address these concerns. Regardless of the individual's decision to pursue a disciplinary resolution, the individual will be provided the option of seeking interim supportive measures.

Interim Supportive and Protective Measures. The university may take reasonable interim supportive measures whether or not a disciplinary resolution is pursued. These supportive measures may include, but are not limited to, mutual no-contact orders, academic support, changes to campus housing and/or working situations, safety planning, and referrals to other relevant resources. The individual will also be informed of their right to seek interim protective measures if the university pursues a disciplinary resolution. Interim protective measures may include, but are not limited to, exclusion from all or part of university housing, prohibition from participating in student activities or representing the university in any official capacity, such as participating on an official team or performing in a band, changes to work schedules or job assignments, and interim suspension.

Alternative Resolution. As appropriate, and if the complainant consents, the university may proceed with an alternative resolution. An alternative resolution is a remedy specifically tailored for the parties' needs and typically does not involve taking disciplinary action against the respondent. An alternative resolution may involve providing the parties with interim support measures, providing targeted or broad-based educational programming or training, and/or it may involve a mutual agreement among the parties to have no future contact with each other. The parties may voluntarily choose to pursue other restorative options under an alternative resolution.

Disciplinary Resolution. As appropriate, the university may proceed with an investigation under the disciplinary resolution process, involving a prompt, equitable, and impartial investigation to determine by a preponderance of the evidence (more likely than not) whether a prohibited act has occurred.

During a disciplinary resolution, both parties have equitable opportunities, including the opportunity to receive a written notice of investigation; to participate in the investigation; to review and present information as evidence; to be accompanied by an advisor of their choice to any meeting; to timely and equal access to information that will be used in disciplinary proceedings; to timely notice of meetings at which their presence will be requested or required; to simultaneous written notice of the outcome, sanction, and rationale; and to appeal the outcome. Where there has been a finding that sufficient evidence exists to support one or more policy violations, the matter is referred to an appropriate disciplinary authority to determine appropriate sanctions or other remedy. Both parties will have the opportunity to submit impact/mitigation statements for the disciplinary authority to consider prior to a determination of sanction.

Sanctions and Corrective Action. Any university student or member of the faculty or staff who violates the prohibitions of the Sexual and Gender-Based Harassment and Interpersonal Violence Policy will be subject to sanction and/or corrective action. Students found responsible for policy violations may be subject to censure, disciplinary probation, restitution, prohibitions against participation in academic honor ceremonies, removal from courses, and expulsion, among other things. Faculty or staff found responsible for policy violations may be subject to oral or written warning, reprimand, censure, training, guidance, and dismissal, among other things. The disciplinary authority considers several factors in issuing a sanction, including, but not limited to, the nature of the conduct, the impact of the conduct on the Complainant, the impact of the conduct on the university community, protection of the university community, and any mitigating, aggravating, or compelling circumstances in order to reach a just and appropriate resolution in every case.

PRIVACY

The university strives to protect the privacy of individuals involved in cases involving sexual and gender-based harassment and intimate partner violence (including domestic and dating violence). To that end, the university does not include names or other personally identifying information of those involved in its publicly available records. The records include the Safety and Security Alerts, the Daily Crime Log, and the Annual Security and Fire Safety Report. In addition, interim supportive and/or protective measures adopted in these cases will also not be disclosed more broadly than necessary to achieve the result sought by such measures.

Information related to a report of prohibited conduct will be handled discreetly and shared with a limited circle of university employees or designees who need to know in order to assist in the assessment, investigation, and resolution of the report and related issues. Individuals will receive training in how to safeguard private information.

The university will make reasonable efforts to investigate and address reports of prohibited conduct under this policy, and information may be disclosed to participants in an investigation as necessary to facilitate the thoroughness and integrity of the investigation. In all such proceedings, the university will maintain the privacy of the parties to the extent reasonably possible.

PREVENTION AND AWARENESS

In addition to its ongoing efforts to eliminate, address, and prevent rape, acquaintance rape, and other forms of sexual violence on its campuses, and in connection with its programs and activities, the university includes in its student, staff, and faculty orientation programs information on prevention and awareness relating to sexual assault, dating violence, domestic violence, and stalking. Programs explain the university's policy prohibiting these types of conduct, provide definitions of prohibited conduct and consent in reference to sexual activity, and offer information about safe and positive options for bystander intervention, criminal reporting options and reporting to campus authorities, and campus disciplinary action, as well as resources to obtain orders of protection and no-contact orders.

The university also conducts ongoing prevention and awareness campaigns for students, staff, and faculty on issues related to domestic violence, dating violence, and stalking. As part of the university's primary prevention and awareness programs, information is provided to incoming students and new employees. Mandatory online training is required for all new students and employees. These modules include information on sexual assault, intimate partner violence (including domestic and dating violence), consent, bystander intervention, university resources, policies, and reporting procedures. The student module also examines the interconnected issues of unhealthy relationships and substance abuse.

In addition to mandatory programs provided for new students, and consistent with NCAA policy, the university also conducts annual training for all athletics department coaches, administrative staff, and students involved in athletics programs. Conducting mandatory athletics training is necessary so that GW's athletics program is knowledgeable about, integrated in, and compliant with GW's Sexual and Gender-Based Harassment and Interpersonal Violence Policy.

Undergraduate incoming students also have a mandatory in-person session that continues what was covered by the online module with particular attention to issues of consent, cultural and climate change, and bystander intervention. First-year students will not be able to register for their spring semester unless both the online and in-person sessions are completed. The university also maintains a standing committee of students, faculty, and staff to address issues of sexual assault, dating violence, domestic violence, stalking, and university policies and procedures.

The FBI's National Incident-Based Reporting System (NIBRS) edition of the UCR defines a sex offense as any sexual act directed against another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the survivor is incapable of giving consent. All forms of sexual violence are violations of GW's Sexual and Gender-Based Harassment and Interpersonal Violence Policy. Prohibited conduct includes sexual and gender-based harassment, sexual assault, sexual exploitation, intimate partner violence, stalking, retaliation, and complicity.

If a sexual assault or rape should occur on campus, staff on the scene, including GWPD, will offer the survivor a wide variety of services. GW's Division of Safety and Security's Office of Advocacy & Support is available to answer questions and assist survivors in identifying and obtaining the necessary resources. GW also has a Sexual Assault Response Consultative (SARC) Team that has trained members who are on-call and available to assist a survivor of sexual assault 24 hours a day. University personnel will assist the survivor in notifying appropriate law enforcement authorities, if the survivor requests the assistance of these personnel. Members of the university community who believe their safety or the safety of others is threatened or who have experienced or witnessed Prohibited Conduct should immediately report the incident to GWPD.

Prevention and Education Programs

The George Washington University offers many ongoing prevention and awareness campaigns for students, staff, and faculty on issues related to sexual and gender-based harassment, sexual assault, sexual exploitation, intimate partner violence (including domestic and dating violence), and stalking. These programs include the same information as the university's primary prevention and awareness programs. Mandatory online training is provided for faculty and staff, and mandatory online and in-person training is provided for students. At training events, Title IX brochures, which explain the university's Sexual and Gender-Based Harassment and Interpersonal Violence Policy and contain resources and reporting options, are distributed. Training topics conducted throughout the year include sexual misconduct, bystander intervention, responding to disclosures, consent, campus reporting processes, campus resources, healthy relationships, and sex and communication. Some of the targeted areas are responsible employees, hearing boards, first responders, post-incident groups, residence halls, duty teams, resident advisors, Greek houses, athletes, student leaders, student organizations, and the broader student body. In addition, an annual Unwanted Sexual Behavior climate survey is administered. Finally, the university partners with Men Can Stop Rape to provide the UASK DC application for mobile phones. The UASK DC app

contains a variety of resources for victims of sexual assault and intimate partner violence on its GW university page. Additional programs and information are available through GWPD's Crime Prevention Division (Academic Center, Rome 101), the Colonial Health Center (801 21st Street, NW, Ground Floor), and the Title IX Office within the Office for Diversity, Equity, and Community Engagement (202-994-7434).


REPORTING AND RESOURCES

1. Reporting to GWPD or MPD

GWPD officers offer information and guidance to survivors when they file a GWPD report. If you choose to report the incident, a GWPD officer will take a statement from you regarding what happened. The officer will ask you to describe the assailant(s) and may ask questions about the scene of the crime, any witnesses, and what happened before and after the incident. You may have a support person with you during the interview and request for a member of the Office of Advocacy & Support to be present as well. NOTE: Reporting an incident is a separate step from choosing to prosecute. When you file a report, you are NOT obligated to continue with legal proceedings or university disciplinary action. If the assault occurred off-campus, report the incident to the Metropolitan Police Department (MPD) or your local police department if you are outside of DC and the George Washington University will assist individuals who are unsure of how and where to report the crime. The reasons for reporting to GWPD are: 1) to take action which may prevent further victimization, including issuing a Safety and Security Alert to warn the campus community of an impending threat to their safety; 2) to apprehend the assailant; 3) to seek justice for the wrong that has been done to you; and 4) to have the incident recorded for purposes of reporting statistics about incidents that occurred on campus. To report an incident, follow the guidelines under "Reporting Procedures" on page 6.

2. The Sexual Assault Response Consultative (SARC) Team

The Sexual Assault Response Consultative (SARC) Team members are trained and prepared to assist individuals who have experienced sexual assault. The team members do not act as counselors, but provide the individual with information and resources in order to make informed decisions regarding the incident. This information would include assisting the individual in identifying his or her medical, legal, counseling, and academic assistance needs; identifying the appropriate campus and/or community services to provide necessary assistance; providing follow-up with the individual to determine



if the services have been obtained and have met his or her needs; and explaining options, such as filing a report with MPD, reviewing disciplinary options available through the university's student disciplinary system, discussing university housing options, and acting as an educator about rape and sexual assault. The coordinator of the SARC Team can be contacted at (202) 994-7434. To reach an on-call SARC Team member 24 hours a day, call (202) 994-7222. 3. Title IX Reporting

Individuals may also consider reporting a sexual violence incident to the GW's Title IX Coordinator, who can provide assistance in addressing the incident by implementing interim measures and alternative or disciplinary resolution (202-994-7434). Haven (haven.gwu.edu) is GW's centralized website designed to bring together on- and off-campus resources, options, information, and immediate and confidential access to help regarding incidents of sexual and gender-based harassment

and intimate partner violence. The website includes definition of prohibited behavior such as sexual assault, intimate partner violence (including domestic and dating violence), sexual and gender-based harassment, sexual exploitation, and stalking.

4. Counseling and Emotional Support

On-Campus

Counseling and Psychological Services

Counseling and Psychological Services at the Colonial Health Center are located at 801 21st Street, NW, Ground Floor.

Counselors can provide confidential support for you during this difficult period. They can inform you of common emotional reactions and discuss coping methods that may assist you immediately following the assault and later. Talking about your concerns with a counselor in a safe and supportive environment may help you sort through your feelings and decide what to do. You do not need to disclose your name if you call the Colonial Health Center for information. Counselors will not reveal your identity to anyone without your permission. Students may be seen on an emergency walk-in basis or by appointment (202-994-5300).

The Office of Advocacy & Support

Formerly known as the Office of Victim Services, the Office of Advocacy & Support is a valuable resource for GW community members who have become the victim of a crime. This office provides confidential services designed to raise awareness and address the needs of those impacted by any form of crime. It also provides information about rights; a space to discuss and process feelings and reactions in confidence; support to individuals who have been victimized; reporting options (on and off campus); means for obtaining interim supportive measures; access to community resources, including counseling, protection orders, victim compensation, and legal representation; accompaniment and coordination of transportation to civil protection order hearings; safety planning; and coordination of transportation to MedStar Washington Hospital Center for a forensic exam. 5. Medical Resources

A special exam should be conducted as soon as possible following an assault to ensure your physical well-being and to collect evidence that may be useful in criminal proceedings. The exam can be conducted without the involvement of law enforcement personnel. Even if you have not been physically hurt, this forensic exam is strongly recommended to maintain all of your legal options. After the evidence is collected, it can be stored in case you wish to press criminal charges. The exam is generally performed by a Sexual Assault Nurse Examiner

(SANE). GWPD will also assist your medical needs by arranging transportation to and from the center where the exam is conducted. Students can receive the exam for free by going to the MedStar Washington Hospital Center (202) 877-7000. In Northern Virginia, a SANE exam may be obtained at INOVA Fairfax Hospital, (703) 776-3199.

Even if you do not have evidence collected at the hospital, it is still important to get medical attention to include treatment of any physical problems and various lab tests for sexually transmitted diseases and pregnancy. This non-emergency treatment can be arranged with your family doctor or with the Colonial Health Center (801 21st Street, NW, Ground Floor, 202-994-6827). If you seek treatment at a local hospital and the police are contacted, this does not mean that you have to proceed with criminal charges. In addition, it is recommended that a survivor use a hospital in the county/state where the incident occurred.

University Disciplinary Action

Any student who has been sexually assaulted by another student or group of students and is considering whether to seek disciplinary action against the assailant(s) should discuss the matter with a Sexual Assault Response Consultative (SARC) team member (202-994-7222) or with the Assistant Director of Sexual Assault Prevention and Response at (202) 994-7434 or shrc@gwu.edu. The procedures to address these incidents are discussed on page 56 of this report.





Sex Offender Registry

The Campus Sex Crimes Prevention Act of 2000 is a federal law that requires institutions of higher education to advise the campus community where information concerning registered sex offenders may be obtained. It also requires sex offenders, already required by state law to register in a state, to provide notice to each institution of higher education in that state, at which the person is employed, carries on a vocation, or is a student.

In DC, convicted sex offenders must register with the Metropolitan Police Department. You can view this information, which appears on MPD's website, by accessing **sexoffender.dc.gov**.

In Virginia, convicted sex offenders must register with the Department of State Police. You can view this information, which appears on the Virginia State Police website, by accessing sex-offender.vsp.virginia.gov/sor.



Alcohol and Drug Policies

GW is committed to promoting the health and safety of its campus community through a program of alcohol education and the implementation of relevant policies. The university enforces all local DC laws regarding the possession, use, and sale of alcoholic beverages, including those prohibiting the consumption of alcoholic beverages by persons under the age of 21 on campus and at university sponsored activities. GW's Alcoholic Beverage Consumption and Distribution Policy and Procedures, as well as the university's penalties for possession or distribution of controlled substances by students on university premises or at institutionally-sponsored activities off campus, are contained online at **studentconduct.gwu.edu/abcd-policy**.

GW is in compliance with the federal Drug-Free Schools and Communities Act of 1989. Each year GW renews its commitment to the letter and spirit of that law with an informational letter to students and employees. While certain aspects of marijuana possession have been decriminalized in DC, the possession of marijuana by someone under 21 years of age, the selling or distributing of marijuana, and the smoking of marijuana in public are still illegal. DC law also allows institutions to prohibit the possession and use of marijuana on their property. In compliance with federal law, GW prohibits the possession and use of marijuana and other illegal drugs on campus.

The university does not condone violations of laws proscribing the possession, use, or sale of alcoholic beverages and possession, use, sale, manufacture, or distribution of illegal drugs. Members of the GW community should know that violation of the laws concerning illegal drugs may lead to disciplinary action, which may include eviction from the residence halls, revocation of other privileges, or suspension or expulsion from the university in order to protect the interests of the university and the rights and safety of others. The Code of Student Conduct specifies the prohibitions and the penalties for violations and is available at **studentconduct.gwu.edu**.

Abuse of alcohol and drugs can have a dramatic impact on professional, academic, and family life. The George Washington University, therefore, encourages members of the community who may be experiencing difficulty with drugs or alcohol to attend programs or to contact one of the following resources available on-campus:

Firearms and Weapons Policies

GW is committed to maintaining a safe and secure environment that supports the academic mission of the university. According to the GW Firearms and Weapons Policy, members of the GW community, including students, faculty, staff, as well as visitors to any GW campus location, are prohibited from possessing firearms, explosives, weapons, or any item that may be construed as such, on the premises of the university or in any building under university control. This prohibition applies regardless of whether a federal or state license to possess the same has been issued to the possessor. There are some limited exceptions to this policy; for example, certified and licensed law enforcement personnel who are authorized to carry a firearm are permitted to do so while on GW property.

All members of the GW community should refer to the Firearms and Weapons Policy, which is available on the university's Compliance Office website at **compliance.gwu.edu/alphabetical-policy-listing**. Additionally, students should refer to the Code of Student Conduct and the Residential Community Conduct Guidelines to identify other policies regarding firearms and weapons that may apply to them. For information regarding proper procedure for active shooter situations, we urge community members to visit **safety.gwu.edu** to view our video on the matter, titled "Shots Fired on Campus." The video is used in trainings with new faculty, staff, and resident advisors.



Emergency Evacuation Procedures and Policies

The George Washington University Emergency Operations Plan addresses the university's response to emergencies by taking an all-hazards approach to both natural and human-caused hazards. Divisions, departments, and offices should familiarize themselves with information in this plan. Individuals should familiarize themselves with the Emergency Response Handbook and other preparedness resources available on the Division of Safety & Security website (safety.gwu.edu).

GW police officers and supervisors are trained in the Incident Command System (ICS), which is utilized when responding to incidents involving the Division of Safety & Security, other GW departments, and local public safety agencies to manage, mitigate, and recover from incidents.

The Division of Safety & Security conducts tests of its emergency plans and capabilities on an annual basis. The tests include but are not limited to drills, tabletops, functional exercises, and full scale simulations. These tests are designed to assess and evaluate the emergency plans and capabilities of the institution.

General information about the emergency response and evacuation procedures for GW is publicized each year as part of the university's Clery Act compliance efforts, and is available on the GWPD website. These tests are designed to assess and evaluate the emergency plans and capabilities of the institution.

NOTIFICATION TO THE GW COMMUNITY ABOUT AN IMMEDIATE THREAT

The Division of Safety & Security and the Division of External Relations monitor events on and around campus and the DC metropolitan area daily. If the Division of Safety & Security confirms that there is an emergency or dangerous situation that poses an immediate threat to the health or safety of some or all members of the GW community, Safety & Security and External Relations will activate emergency notification procedures to provide immediate notification of the threat to the GW community. Safety & Security and External Relations will, without delay and taking into account the safety of the community, determine the content of the notification and initiate notification, unless issuing a notification will, in the judgment of the first responders (including, but not limited to GWPD, MPD, and/or the DC Fire and Emergency Medical Services), compromise the efforts to assist a victim or to contain, respond to, or otherwise mitigate the emergency.

In the event of a serious incident that poses an immediate threat to members of the GW community, the university has various systems in place for communicating information guickly. Some or all of these methods of communication may be activated in the event of an immediate threat to the GW campus community. These methods of communication include GW Alert, a system that provides voicemail and/or text message alerts to members of the GW community. Students, faculty, and staff are automatically signed up for email alerts through their official GW email address. Alerts are often sent out through official GW social media, including Facebook (/GeorgeWashingtonUniversity) and Twitter (@GWtweets). In emergency situations, alerts may also appear at the top of university webpages. Campus Advisories is the university's primary website used for communicating emergency preparedness and incident-related information to the GW community. Individuals can also call the GW Information Line for updates (202-994-5050). Members of the larger community who are interested in receiving information about emergencies on campus should use the Campus Advisories website, official GW social media, or call the GW Information Line.

GW community members are encouraged to notify GWPD of any situation or incident on campus that involves a significant emergency or dangerous situation that may involve an immediate or ongoing threat to the health and safety of students, faculty, staff, or visitors on campus. GWPD has the responsibility of responding to, and summoning the necessary resources, to mitigate, investigate, and document any situation that may cause a significant emergency or dangerous situation. In addition, GWPD has a responsibility to respond to such incidents to determine if the situation does in fact, pose a threat to the community. If so, federal law requires that the institution notify the campus community or the appropriate segments of the community that may be affected by the situation.

EMERGENCY RESPONSE AND EVACUATION TESTING PROCEDURES

The Division of Safety and Security works with DC FEMS to conduct 4 emergency evacuation drills per year. Students learn the locations of the emergency exits in the buildings and are provided guidance about the direction they should travel when exiting each facility for a building evacuation.

Educational information is posted on each floor of the residential halls and referenced during annual drills. In addition to educating the occupants of each building about the evacuation procedures during the drills, the process also provides the university an opportunity to test the operation of fire alarm system components.

Evacuation drills are monitored by Health & Safety, GWPD, and GW Housing staff to evaluate egress and behavioral patterns. Reports are prepared by participating departments that identify deficient equipment so that repairs can be made immediately. Recommendations for improvements are also submitted to the appropriate departments/offices for consideration.

Students receive information about evacuation and shelter-in-place procedures during their first floor meetings and during other educational sessions that they can participate in throughout the year. The residence hall staff members are trained in these procedures as well and act as an on-going resource for the students living in residential facilities. GW will publish a summary of its emergency response and evacuation procedures in conjunction with at least one drill or exercise each calendar year.

EMERGENCY MEDICAL RESPONSE PROCEDURES

Foggy Bottom and Mount Vernon Campuses

Students, faculty, staff, and visitors should report any emergency medical situations to GWPD immediately at extension 4-6111 (2-6111 at MVC) or, from outside the university phone system, at (202) 994-6111 (202-242-6111 at MVC). The GWPD dispatcher will send GWPD officers and (if on duty) on-call members of the Emergency Medical Response Group (EMeRG) to the scene. EMeRG at GW is a recognized basic life support (BLS), first responder agency within DC. EMeRG's certified personnel operate a BLS ambulance and provide quality emergency medical services in a variety of settings, including campus coverage and special events. If EMeRG is not in service, GWPD will notify DCFEMS of an incident.

VSTC, Academic Centers, and Off-Campus Locations

Students, faculty, staff, and visitors at VSTC and off-campus locations should call **911** to report a medical emergency.

Annual Fire Safety Report

The George Washington University publishes this fire safety report as part of its annual Clery Act Compliance. This report contains information regarding the fire safety practices and standards for GW, including statistics concerning the number of fires, the cause of each fire, the number of injuries and deaths related to a fire, and the value of the property damage caused by a fire. This report is available for review on the GWPD website at **safety.gwu.edu/reports-and-records**. A copy may be obtained by making a request to GWPD at (202) 994-6110.

FIRE SAFETY

A daily fire log is available for review 24 hours a day on the GWPD website or in person at Rome Hall 101, from 8 a.m.-5 p.m. Monday through Friday, excluding holidays. The fire log includes information about fires that occur in residential facilities, including the nature, date, time, and general location. A fire is defined as any instance of open flame or other burning in a place not intended to contain the burning or in an uncontrolled manner. If a fire occurs in a GW building, community members should immediately notify GWPD at (202) 994-6111 or 911. When calling, please provide as much information as possible about the location, date, time and cause of the fire. GWPD will initiate a response, as the department has a direct dial phone line to the DC Office of Unified Communications and can contact the fire department guickly through this communication link. If a member of the GW community finds evidence of a fire that has been extinguished, and the person is not sure whether GWPD has already responded, the community member should immediately notify GWPD to investigate and document the incident.

The university takes fire safety seriously and has established fire safety programs for students living in on-campus residence halls. Fire evacuation plans have been developed for each residence hall and copies of these plans can be found on the inside of the door of each room. If your room is missing a plan on the back of your door, contact your resident advisor for assistance in obtaining a copy. The university also has specific fire safety programs for employees and contractors working on campus, such as CPR training and fire extinguisher training. Fire safety training can be provided upon request by calling Health & Emergency Management Safety at (202) 994-4347.



FIRE SAFETY SYSTEMS IN RESIDENTIAL FACILITIES

A majority of university buildings are equipped with automatic fire detection and alarm systems that are constantly monitored by staff at GWPD. Fire drills are conducted twice a year in all residence halls at the Foggy Bottom and Mount Vernon campuses. The first drill is scheduled early in the fall semester and the second drill is conducted during the spring semester. All fire drills are unannounced. The Fire Safety Systems in Residential Facilities charts displays information about fire detection, notification, and suppression systems, and the number of fire drills in each residential facility.

Buildings are equipped with a variety of features that are designed to detect, stop and/or suppress the spread of a fire. A door can be the first line of defense against the spread of smoke or fire from one area to another. Some doors, such as fire doors in corridors or stairwells of residence halls, are designed to stand up to fire longer than those of an individual room. It is important that these doors stay closed for them to work. Additionally, if a door has a device that automatically closes the door, it should NOT be propped open. Sprinklers are 98% effective in preventing the spread of fire when operating properly. DO NOT obstruct the sprinkler heads with materials like clothing hanging from the piping. Smoke detectors cannot do their job if they are disabled or covered by the occupant, which is a violation of university policy. The George Washington University campuses are smoke-free, both indoors and outdoors, per Housing contracts within the residence halls and University Policy, which governs all GW property.

FIRE SAFETY TIPS

- If you are cooking, never leave your stove or oven unattended
- Do not assume an alarm is a drill
- In case of fire, use stairs, do not use elevators; if you are unable to use the stairs, call GWPD for help
- Know at least two different ways out of your residence hall or office building
- If unable to exit the building, go to the nearest exit stairwell or safe area of refuge and call GWPD (202-994-6111) or 911 to report your location
- If trained, use a fire extinguisher if the fire is small and contained, and room is not filled with smoke

IN THE EVENT OF A FIRE

Fire alarms alert community members of potential hazards and community members are required to heed their warning and evacuate buildings immediately upon hearing a fire alarm in a facility. Individuals who fail to evacuate a building promptly are subject to be written up for a University Policy Violation. Follow the following procedures in the event of a fire:

- Pull the fire alarm
- Leave the building immediately using the closest emergency exit
- Close doors behind you
- Call GWPD (202-994-6111) or 911 when safe to do so
- Assemble in an area away from the building
- Re-enter the building only when instructed by officials

PLANS FOR FUTURE IMPROVEMENTS IN FIRE SAFETY

The university continues to assess and upgrade fire safety equipment as an ongoing process to ensure that all equipment meets National Fire Safety Association (NFSA) standards. Future improvements will be made as needed as part of the ongoing assessment process.



HEALTH AND SAFETY INSPECTIONS

Health & Safety performs Residence Hall health and safety inspections twice per year. Inspections will be announced only during the first round of the fall semester. All other inspections are unannounced. The inspections are designed to find and address or remove safety violations. Students are required to read and comply with the Residential Community Conduct Guidelines (RCCGs), which include the inspections and all other rules and regulations for residential buildings. The inspections include, but are not limited to, a visual examination of electrical cords, sprinkler heads, smoke alarms, fire extinguishers, and other life safety systems.

In addition, each room will be examined for the presence of prohibited items (e.g., sources of open flames, such as candles; non-surge protected extension cords; halogen lamps; portable cooking appliances in non-kitchen areas) or prohibited activity (e.g., smoking in the room, tampering with life safety equipment, possession of pets, etc.). This inspection will also include a general assessment of food and waste storage and cleanliness of the room. Prohibited items will be immediately confiscated and donated/discarded if found, without reimbursement. The following is a list of prohibited items and are considered a violation of university policy as of September 2018. The prohibited items list is subject to revision by the Division of Safety & Security as needed.

- Candles, incense, and fragrance burners
- Non-surge protected extension cords
- Halogen lamps (all desk and floor lamps)
- Lanterns/oil lamps and flammable liquids
- Lighter fluid liquids (Naphtha) (no more than 4 ounces)
- Microwaves or refrigerators (unless supplied by GW Facilities Services)
- Space heaters (unless supplied by GW Facilities Services)
- Live holiday decorations (holiday trees, garlands, etc.)
- Fireworks
- Hoverboards (self-balancing scooters, battery-operated scooters, handsfree segways)
- Unmanned Aircraft System (UAS), commonly known as a drone
- All cooking items in rooms without a kitchen: hot plates, crock pots, waffle irons, toasters, toaster ovens, George Foreman grills, sandwich makers, popcorn poppers, etc.
- Weapons: pocket knives; knives in a sheath; spears; swords; souvenir weapons; firearms; ammunition; BB, air pellet, or paintball guns; taser or stun guns; expandable batons or impact weapons; and 3D printers capable of producing any of the prohibited items
- Chemical mace and/or pepper spray (no more than 0.5 ounces)
- Alcohol (if underage)
- Illegal drugs, drug paraphernalia, or drug manufacturing materials
- Hazardous materials (not including household cleaners)
